Regular Meeting, Monday, January 4, 2021

The regular meeting of the Village of Elbridge Board of Trustees was called to order at 7:00 p.m. in the Municipal Offices, 210 West Main Street. Trustees present were Harris, Murray, Ely and DeMarco with Mayor DeCola presiding. Clerk-Treasurer Caron was also present.

Resident Robert Surdam and Resident/Budget Officer Frederick Weisskopf were present.

Mayor DeCola led everyone in the Pledge of Allegiance.

Mayor DeCola recognized Mr. Surdam who stated that he still has dirty water and is upset that the Village has not remedied the problem as promised. He wants a clean out installed. Mayor DeCola stated that Village DPW and Water Engineers have not been able to locate the water line and Barton & Loguidice did not think a clean out was necessary to fix the problem. Mr. Surdam is the only one in the area with dirty water. The water line is scheduled to be dug up and redone with the water system improvement project in the future. The Board assured Mr. Surdam that Village DPW will work on it in the next week.

Mr. Surdam left at 7:23 p.m.

A motion was offered by Trustee DeMarco, seconded by Trustee Ely, and carried unanimously to forgo the reading of the minutes from the last organizational and regular meetings on December 7, 2020.

The minutes of the organizational meeting and last regular meeting on December 7, 2020 were accepted on a motion made by Trustee Harris, seconded by Trustee Ely and carried unanimously.

Reports of Officers and Committees -

The Board reviewed the Treasurer's Report and approved it on a motion made by Trustee Ely, seconded by Trustee DeMarco and carried unanimously.

Trustee Harris presented the Code Enforcement Report who moved for its acceptance, seconded by Trustee Murray and carried unanimously.

There was no Historian's Report.

There was no Public Works Report.

Mayor DeCola said that DPW will pick up Christmas Trees on Thursday. They are hoping to remove the Christmas decorations along Main Street soon. DPW has built a rack to store them. Funds remain in this year's budget for new cabinets and appliances for the community room kitchen.

Trustee, Mayor and Attorney Reports – Trustee Harris – Nothing to report.

Trustee Murray - No report.

<u>Trustee Elv</u> – Nothing at this time.

Trustee DeMarco - No report.

Old Business

The Board is in receipt of a letter dated January 4, 2021 from Planning Board Chairman Dennis Pelmear with additional information regarding the number of chickens allowed.

Trustee DeMarco offered a motion, seconded by Trustee Murray, and carried unanimously to acknowledge the Planning Board's recommendations regarding amending Local Law Chapter 48 Farm Animals; specifically to allow chickens in the Village of Elbridge and authorizing Attorney Armani's review.

A Public Hearing will be held.

New Business

A motion was offered by Trustee Ely, seconded by Trustee Murray, and carried unanimously authorizing the Mayor to execute a Fuel Agreement with Jordan-Elbridge Central School District to sell fuel to the Elbridge Fire Department.

The Village received a copy of a letter dated December 4, 2020 from NYSDOT stating that after conducting a study they have denied a request for a street light at the corner of Sandbank Road and Route 5 East.

Mayor DeCola stated that the next step for the Joint Water System Improvement Project is for the Village to contract with third party fiscal advisors. Mayor DeCola will execute a Financial Advisory Services Agreement along with the Village of Jordan and the Town of Elbridge.

Anticipated grant monies totaling nine million dollars; three million dollars each for the Village of Elbridge, Village of Jordan and the Town of Elbridge will have to be managed. Sunview Drive homeowners have opted out of the project.

A motion was offered by Trustee DeMarco, seconded by Trustee Ely, and carried unanimously authorizing the Mayor to execute the Annual Software Support Contracts with Williamson Law Book Company.

The Board of Trustees will hold a special meeting/budget workshop on Monday, February 1, 2021 at 5:00 p.m. Clerk-Treasurer Caron will advertise.

There was some discussion regarding 2021-2022 budget figures.

Budget Officer Fred Weisskopf will start preparing a tentative budget for review at future meetings.

Fire Chief Paul Czarnecki, Asst. Chief Gordon Franz and EFD President Robert Tackman arrived at 8:32 p.m.

Chief Czarnecki presented the Fire Department Report for December. Trustee Ely moved for its acceptance, seconded by Trustee Murray, and carried unanimously.

Chief Czarnecki stated that they are working on grant applications.

The Department has had some personnel changes. They will provide an updated roster.

The Doctor's office has not been able to provide firefighter physicals this year due to COVID-19.

A motion was offered by Trustee Ely, seconded by Trustee Harris, and carried unanimously, to enter into executive session at 8:57 p.m. to discuss personnel matters.

Budget Officer Frederick Weisskopf and Clerk-Treasurer Caron were invited to stay.

Trustee Harris offered a motion, seconded by Trustee DeMarco, and carried unanimously, to exit executive session at 9:16 p.m.

No formal action was taken.

Fred Weisskopf left at 9:17 p.m.

Fire Chief Paul Czarnecki and EFD President Robert Tackman returned.

A motion was offered by Trustee Ely, seconded by Trustee DeMarco, and carried unanimously, to enter into executive session at 9:17 p.m. to discuss a personnel matter.

NOW, THEREFORE BE IT RESOLVED that the Village Board of Trustees of the Village of Elbridge hereby authorizes the Mayor to execute the "Intermunicipal Agreement for the Construction, Operation, Maintenance and Financing of the Proposed Town of Elbridge, Village of Jordan and Village of Elbridge Joint Water Project."

RESOLUTION # 2-2021

Village of Elbridge Board of Trustees Regular Meeting Monday, March 1, 2021

A RESOLUTION AUTHORIZING, SUBLECT TO PERMISSIVE REFERENDUM, THE CONSTRUCTION OF IMPROVEMENTS TO THE WATER STORAGE AND DISTRIBUTION SYSTEM, IN AND FOR THE VILLAGE OF ELBRIDGE, ONONDAGA COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$5,260,219.05 AND AUTHORIZING THE ISSUANCE OF \$5,260,219.05 SERIAL BONDS OF SAID VILLAGE TO PAY THE COST THEREOF.

At a regular meeting of the Board of Trustees of the Village of Elbridge, held at the Village Hall, 210 West Main Street, in said Village of Elbridge, Onondaga County, New York, on the 1st of March, 2021, commencing at 7:02 p.m. the following resolution was offered by Trustee Harris, and seconded by Trustee DeMarco, who moved for its adoption:

WHEREAS, said capital project hereinafter described, as proposed, has been determined to be a Type I Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, which it has been determined will not have any significant adverse impact on the environment; and

WHEREAS, it is now desired to authorize the financing thereof, NOW, THEREFORE,

BE IT RESOLVED, by the affirmative vote of not less than two-thirds of the total voting strength of the Board of Trustees of the Village of Elbridge, Onondaga County, New York (the "Village"), as follows:

- Section 1. The Village's share of the cost of the construction of improvements to the water storage and distribution system, in and for the Village of Elbridge, Onondaga County, New York, including original furnishings, equipment, machinery, apparatus, appurtenances, and incidental improvements and expenses in connection therewith, is hereby authorized, subject to permissive referendum, at a maximum estimated cost of \$5,260,219.05.
- Section 2. The plan for the financing of the aforesaid maximum estimated cost is by the issuance of \$5,260,219.05 serial bonds of said Village, hereby authorized to be issued therefor pursuant to the provisions of the Local Finance Law.
- Section 3. It is hereby determined that the period of probable usefulness of the aforesaid class of objects or purposes is 40 years, pursuant to subdivision 1 of paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized will exceed five years.
- Section 4. The faith and credit of said Village of Elbridge, Onondaga County, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. There shall annually be levied on all the taxable real property of said Village, a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.
- Section 5. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Village Treasurer, the chief fiscal officer. Such notes shall be of such terms, forms and contents, and shall be sold in such manner, as may be prescribed by said Village Treasurer, consistent with the provisions of the Local Finance Law.
- Section 6. The powers and duties of advertising such bonds for sale, conducting the sale and awarding the bonds, are hereby delegated to the Village Treasurer, who shall advertise such bonds for sale, conduct the sale, and award the bonds in such manner as the Village Treasurer shall deem best for the interests of said Village, including, but not limited to, the power to sell said bonds to the New York State Environmental Facilities corporation; provided, however, that in the exercise of these delegated powers, the Village Treasurer shall comply fully with the provisions of the Local Finance Law and any order or rule of the State Comptroller applicable to the sale of municipal bonds. The receipt of the Village Treasurer shall be a full acquittance to the purchaser of such bonds, who shall not be obligated to see to the application of the purchase money.
- Section 7. All other matters except as provided herein relating to the serial bonds herein authorized including the date, denominations, maturities and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the consolidation with other issues, and also the ability to issue serial bonds with substantially level or declining annual debt service, shall be determined by the Village Treasurer, the chief fiscal officer of such Village. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the Village Treasurer shall determine consistent with the provisions of the Local Finance Law.

Section 8. The Village Treasurer is hereby further authorized, at the Village Treasurer's sole discretion, to execute a project finance and/or loan agreement, and any other agreements with the New York State Department of Health and/or the New York State Environmental Facilities Corporation, including amendments thereto, and including any instruments (or amendments thereto) in the effectuation thereof, in order to effect the financing or refinancing of the class or objects or purposes described in Section 1 hereof, or a portion thereof, by a bond, and/or note issue of said Village in the event of the sale of same to the New York State Environmental Facilities Corporation.

Section 9. The power to issue and sell notes to the New York State Environmental Facilities Corporation pursuant to Section 169.00 of the Local Finance Law is hereby delegated to the Village Treasurer. Such notes shall be of such terms, form and contents as may be prescribed by said Village Treasurer consistent with the provisions of the Local Finance law.

Section 10. The validity of such bonds and bond anticipation notes may be contested only if:

- 1) Such obligations are authorized for an object or purpose for which said village is not authorized to expend money, or
- 2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or
- Such obligations are authorized in violation of the provisions of the Constitution.

Section 11. This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150-2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

Section 12. Upon this resolution taking effect, the same shall be published in summary form in the official newspaper of said Village for the purpose, together with a notice of the Village Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.

Section 13. THIS RESOLUTION IS ADOPTED SUBJECT TO PERMISSIVE REFERENDUM.

2021-2022 BUDGET HEARING

A motion was offered by Trustee Harris, seconded by Trustee Murray, and carried to open the Public Hearing for the 2021-2022 Budget at 7:03 p.m.

The legal notice was published in the March 17th issue of the Eagle News Press-Observer.

A motion was offered by Trustee Murray, seconded by Trustee Harris, and carried to forgo the reading of the legal notice.

Deputy Clerk Kaylee Landers joined the meeting at 7:04 p.m.

Mayor DeCola asked once if anyone present wished to speak in favor of the budget.

Mayor DeCola asked twice more if anyone present wished to speak in favor of the budget; there was no one.

Resident Don Demo arrived at 7:05 p.m.

Mayor DeCola then asked three times if anyone present wished to speak in opposition of the proposed budget; there was no one.

There was some discussion regarding funding the Village will receive for the Joint Water System Improvement Project.

All who wished to be heard were heard.

The hearing was closed at 7:10 p.m. on a motion made by Trustee Ely, seconded by Trustee Murray, and carried.

A resolution was offered by Trustee Murray, and seconded by Trustee Harris, WHEREAS, the tentative budget for the fiscal year 2021-2022 was duly prepared and presented to the Board by the Clerk on March 18th, and a duly advertised public hearing was thereon held April 5th, RESOLVED, pursuant to Section 5-508, Subdivision 4 of the Village Law, the said tentative budget, as changed, altered and revised, be and hereby is adopted as the budget of the Village of Elbridge for the year 2021-2022 in the amount of \$569,428.00 for General fund and \$308,439.67 for Water fund for a grand total of \$877,867.67 with wages and salaries adopted as shown in Schedule 6 of the budget document. Upon roll call vote each voted as follows: Mayor DeCola, Yes; Trustee Ely, Yes; Trustee DeMarco, Absent; Trustee Murray, Yes; Trustee Harris, Yes. The question of the resolution was thereupon duly adopted.

Mayor DeCola recognized Mr. Surdam who thanked the board for completing the work on the water line, however he was not happy it took so long. He would like the Board to consider reimbursement for the cost of a new water heater. Mayor DeCola stated that there is no precedent that the Village has ever done that. It is the homeowner's responsibility to maintain their water heaters.

Mr. Surdam left at 7:15 p.m.

Mayor DeCola recognized Mr. Fesko who inquired about the timeliness of Turbidity Violation Notices. Mayor DeCola explained that it typically takes about two weeks to receive notification from the Onondaga County Health Department after which time the notices are prepared and mailed to water customers. The Village is required to complete the process within thirty days of the violation date.

Mr. Fesko asked if there are alternative options to pay water bills besides a personal check. Water customers can pay by cash in the office, money order or credit card in person or by phone. Customers can utilize bill pay through their bank. There is no online option at this time.

Mr. Fesko wondered why Spectrum is the only available internet access. He has tried to get FIOS (Verizon), but has been told they are not in the area. Mayor DeCola explained that the County Executive has obtained funding to address this issue countywide in future months.

Trustee DeMarco joined the meeting at 7:28 p.m.

Mr. Fesko asked if a date had been set for the Public Hearing regarding amending Code - Chapter 48 to allow chickens. Mayor DeCola stated that he has had discussions with Attorney Armani regarding the safety of holding the hearing relative to COVID-19 issues. The Board wants the public to feel comfortable attending.

He also wondered if the Village had looked into solar programs. The Village has not,

however the Town of Elbridge has.

He wanted the Board to know that he likes the extension of the turning lane through the village and the new street lights.

A motion was offered by Trustee Murray, seconded by Trustee DeMarco, and carried unanimously to forgo the reading of the minutes from the last regular meeting on March 1, 2021.

The minutes of the last regular meeting on March 1, 2021 were accepted on a motion made by Trustee Harris, seconded by Trustee Murray and carried unanimously.

A motion was offered by Trustee Harris, seconded by Trustee Ely, and carried unanimously to forgo the reading of the minutes from the special meeting on March 18, 2021.

The minutes of the special meeting on March 18, 2021 were accepted on a motion made by Trustee DeMarco, seconded by Trustee Murray and carried unanimously.

Reports of Officers and Committees -

The Board reviewed the Treasurer's Report and approved it on a motion made by Trustee DeMarco, seconded by Trustee Murray and carried unanimously.

Trustee Harris presented the Code Enforcement Report for March who moved for its acceptance, seconded by Trustee Murray and carried unanimously.

There was no Public Works Report.

Trustee Murray presented the Historian's Report who moved for its acceptance, seconded by Trustee Ely and carried unanimously.

The Historian is asking the Board's permission to use the Village's copier. The Board has no issue with her using the old copier as long as it runs and/or until toner is gone. DPW can move it to the Library for their use. The Board would like the Historian to attend a future meeting to discuss the process and her future plans. Why copies? Should historical records be saved digitally?

Trustee, Mayor and Attorney Reports -

<u>Trustee Harris</u> – DPW should begin the process of cleaning up yards throughout the village from plow damage.

Brush pickup is scheduled to begin on the second and fourth Tuesdays in May. There is quite a lot out already. The Board would like them to begin the fourth Tuesday of April.

<u>Trustee Murray</u> – He spoke with Vern Richardson regarding Memorial Day. Jordan is planning on having their parade. The Jordan-Elbridge Marching Band is participating. He would like the Village of Elbridge to hold its' ceremony and parade as in the past. Board Members have concerns about public safety. He will contact Ken Bush to discuss what they are doing.

A motion was offered by Trustee Murray, seconded by Trustee Ely and carried unanimously to reimburse the American Legion \$120.00 for one (1) box of grave marker American flags.

<u>Trustee Ely</u> – Nothing at this time.

<u>Trustee DeMarco</u> — He has tried to contact the Kingston Road property owner regarding the Joint Water System Improvement Project, but has not heard back from them.

New Business

A motion was offered by Trustee Ely, seconded by Trustee Harris, to increase water rates effective June 1, 2021 for inside customers from \$18.50 minimum per one thousand cubic feet of water per unit and \$1.85 per one hundred cubic feet additional to \$20.75 minimum per one thousand cubic feet of water per unit and \$2.08 per one hundred cubic feet additional; for outside customers from \$37.00 minimum per one thousand cubic feet of water per unit and \$3.70 per one hundred cubic feet additional to \$41.50 minimum per one thousand cubic feet of water per unit and \$4.15 per one hundred cubic feet additional; and for Hartlot customers from \$35.00 minimum per seven thousand gallons of water per unit and \$3.50 per one thousand gallons additional to \$39.65 minimum per seven thousand gallons of water per unit and \$3.97 per one thousand gallons additional. The base fee for the quarterly UV/LT2 charge will remain at \$6.50 and \$.30 per one hundred cubic feet additional for inside and outside customers and \$.40 per one thousand gallons additional for Hartlot customers. Upon roll call vote each voted as follows: Mayor DeCola, Yes; Trustee Ely, Yes; Trustee DeMarco, No; Trustee Murray, Yes; Trustee Harris, Yes. The question of the resolution was thereupon duly adopted.

A motion was offered by Trustee Ely, seconded by Trustee Harris, and carried to open the Public Hearing to take and hear comments relating to Chapter 48 ANIMALS; specifically Section 48.3 K pertaining to and seeking general public comment on whether the Village should consider to amend the Village Code which currently prohibits any yard or pen for keeping of chickens.

The legal notice was published in the May 12th issue of the Eagle News Press-Observer.

Trustee DeMarco joined the meeting at 7:04 p.m. Resident Margo Spain arrived at 7:05 p.m.

Mayor DeCola recognized Laura Fesko who is opposed to allowing chickens in the village. Two of her neighbors have chickens. They should have known they are not allowed. Their pens/coops obstruct her view and the smell is offensive. She believes it de-values housing in the area. She questioned whether this action is cost effective. Should the Village spend taxpayer monies for lawyer fees and costs associated with amending the code. If the Board decides to allow, she suggested that the home owner be required to own a two acre parcel. She is afraid that the village will be overrun with chickens.

Ron Fesko is also opposed and said he is afraid that the Board will be setting a precedent if they amend the code every time a resident pleads ignorance of the law. It is the resident's responsibility to verify if chickens are allowed. His neighbor's chickens make a lot of noise.

Mayor DeCola stated that he has spoken with several assessors and realtors who have said that allowing chickens does not affect assessment or de-value property.

Ron Fesko stated that chickens are prone to disease. They attract predators. He has seen fox in the area. He has also seen pest control at his neighbor's homes. He feels that the Village has done a poor job of enforcing the code.

Special Meeting/Public Hearing, Wednesday, May 19, 2021 cont.

Trustee Ely spoke about lack of a Code Enforcement Officer for a time. He stated that Code Enforcement Officer Tanner has been trying to catch up. He is enforcing the codes and is very timely about getting back to people.

Margo Spain said that it is nice to have your own eggs. She is not opposed and feels that if people are responsible and don't offend their neighbors it should be allowed, but doesn't think it can happen in the Village of Elbridge.

Mayor DeCola asked if anyone present wished to speak in favor of amending Village Code to allow the keeping of chickens; there was no one.

All who wished to be heard were heard.

Mrs. Spain left at 7:43 p.m.

Mr. And Mrs. Fesko left the meeting at 7:48 p.m.

The hearing was closed at 7:48 p.m. on a motion made by Trustee DeMarco, seconded by Trustee Harris, and carried unanimously.

Board Members discussed the issue. They will make a decision at their next regularly scheduled meeting on June 7, 2021.

The meeting was adjourned at 8:10 p.m. on a motion made by Trustee DeMarco, seconded by Trustee Ely, and carried unanimously.

Reports of Officers and Committees -

The Board reviewed the Treasurer's Report and approved it on a motion made by Trustee Murray, seconded by Trustee Harris and carried unanimously.

Trustee Harris presented the Code Enforcement Report for May who moved for its acceptance, seconded by Trustee Murray and carried unanimously.

A motion was offered by Trustee Ely, seconded by Trustee Murray and carried unanimously authorizing Mayor DeCola to send letters of congratulations on behalf of the Board of Trustees to Emily Mocyk and Frankie Brown of Elbridge Boy Scout Troop 52/1 G, acknowledging them for having reached the rank of Eagle Scout. These two young women are first female Eagle Scouts in Central New York.

Mayor DeCola read Chapter 48 ANIMALS Sections 48.1, 48.2 and 48.3; specifically as it is currently, as well as the Planning Board's proposed Exception: Chapter 48 Section M to allow chickens. He also read the proposed Chicken Permit Application. After some discussion the Board of Trustees made changes as follows:

Chapter 48 Section M

(1) (c) The number of chickens shall be limited to a maximum of SIX (6);

(1) (m) Any violation of this chapter shall be subject to a fine of \$50.00 for a first offense, \$100 for a second offense, and revocation of permit for a third offense.

The Application Fee will be \$150.00.

Trustee Ely offered a motion, seconded by Trustee Harris, and carried on roll call vote, each voting as follows: Trustee Harris, Yes; Trustee Murray, Yes; Trustee Ely, Yes; Trustee DeMarco, Yes; Mayor DeCola, Yes to amend Chapter 48 "Animal Control Law of the Village of Elbridge" by adding Exception: Chapter 48 Section 48-3 M to allow the keeping of chickens and hens after obtaining a written permit effective immediately after confirmation from Attorney Armani.

Code Enforcement Officer Tanner will have to contact all residents in violation.

Mr. Fesko stated that he was disappointed, but not surprised.

Mayor DeCola hopes that if the new law is followed properly, there shouldn't be problems in the future.

The Board of Trustees has been exploring options regarding garbage and recycling removal.

WHEREAS, providing funding options for home repairs is in the best interest of the residents of the Village of Elbridge;

The regular meeting of the Village of Elbridge Board of Trustees was called to order at 7:00 p.m. in the Municipal Offices, 210 West Main Street. Trustees present were Ely and Murray with Mayor DeCola presiding. Deputy Clerk Kaylee Landers was also present. Trustee Harris, Trustee DeMarco, and Clerk Treasurer Caron were absent.

Taylor Bottar, Jessica Martinez, and Alex Hess from Barton and Loguidice were also present.

Mayor DeCola led everyone in the Pledge of Allegiance.

Mayor DeCola recognized Joe Zanchowski who addressed the board with concerns about the drainage pipes on Crossett Rd. He stated that just before Fred Weisskopf's house; 5496 Crossett Rd. the drainage pipe is overgrown and covered with weeds. Mr. Zanchowski stated that it's causing issues on Willow Lane due to water being unable to drain properly, and requested they be cleaned up. Mayor DeCola recognized his concerns, and stated he will do his best to have it cleaned within the week.

Mayor DeCola then recognized Mr. Fesko who inquired what the mask guidelines for Village Hall were. He stated he did not see a sign indicating if they were mandated or not. Mayor DeCola asked Deputy Clerk Landers if there was a sign on the window of the entry to the building, at which time Deputy Clerk Landers responded that it had been taken down but will be replaced with another.

Mayor DeCola then invited Barton and Loguidice to give an update on the Joint Water Project. Taylor from Barton and Loguidice gave a briefing about the Engineer's Report and operator workshop he attended with Pat Burns, Fred Dirisio, Brad Milton and Marty Williams. Taylor stated that it had been requested from the operator that more pipe be replaced than originally planned. 50,000 linear feet had originally been figured into the project. The operator is now requesting that 65,000 linear feet be allotted. Additional recommendations made included a chlorine booster station, and that the Crossett Rd. station that is buried in the field be moved closer to the road. Taylor stated that the project is currently at the amendment phase. Budget Officer Fred Weisskopf inquired about the possibility of stimulus money being available for the project. Trustee Murray asked if water customers who had previously wanted to stay on wells would be able to tap into the new water system if they changed their minds. Codes Enforcement Officer Howard Tanner addressed the Board about a current code that he believes creates a conflict between the Zoning Board of Appeals and the Planning Board.

He also discussed a current code that dictates the size of an additional structure being erected on a property is dependent on the size of the home on the property. He recommended that the Board look at both sections of the code as he believes they are outdated.

<u>Trustee Ely –</u> He stated that they still need to work on weeding throughout the Village. The State Troopers Barracks and Fire House were areas of concern. Trustee Ely recommended that they remove all of the current landscaping around the sign at the State Troopers Barracks. He also suggested taking down the flag poles, so they can be repositioned, and repainted. He stated that the flag/ flag pole at the Village Office is still in need of a light. He also said that weed whacking needs to be done around the fire hydrants.

He then inquired about when sidewalks, and black top would be receiving necessary repairs throughout the village. Mayor DeCola said Village of Elbridge DPW would be working with the Town of Elbridge DPW to repair blacktop. Mayor DeCola said he would have the sidewalks looked at and addressed.

Mayor DeCola stated that the bush at the four corners would be getting pulled out and replaced with two new bushes. He said that the poison ivy at the library would be getting removed, as well as the weeds getting pulled, and then grass seed will be put down.

Budget Officer Weisskopf expressed concern regarding the short fall of revenue from garbage sticker sales. There was some discussion about increasing sticker prices. Mayor DeCola stated that the Board would be preparing a letter for residents on the issue.

Mayor DeCola stated that the Village has been working towards becoming a clean energy community. Two components remain. First a conversion to LED lights at Village Hall, the Fire Hall, and the Library. Second, installation of charging stations for electric vehicles.

Town of Elbridge Supervisor Vern Richardson stated that the Town would like to extend the Intermunicipal Agreement relative to managing Seymour Lofft Park. After some discussion it was decided that the agreement would be extended an additional 5 years.

Regular Meeting, Monday, November 1, 2021

Bal 9/30/2021

The regular meeting of the Village of Elbridge Board of Trustees was called to order at 7:00 p.m. in the Municipal Offices, 210 West Main Street. Trustees present were Harris, Murray, Ely and DeMarco with Mayor DeCola presiding. Clerk-Treasurer Caron and Deputy Clerk Kunz were also present.

Resident/Budget Officer Frederick Weisskopf and Residents Margo and Courtney Spain, Cindy Sanderson, Marcelline Mitchell, Tim Burns, Carrie Laug, Amy Thorpe and Jennifer Thorpe were present.

Town Supervisor Vern Richardson, Town Councilman Douglas Blumer, Taylor Bottar and Jessica Martinez, Barton & Loguidice, Patrick and Jaqui McCarthy, Dan Conroy, Jennifer Schrader, David and Jennifer Weaver were also present.

Mayor DeCola led everyone in the Pledge of Allegiance.

Mayor DeCola introduced and welcomed Deputy Clerk Tammy Kunz. Mayor DeCola also informed those present that this is Clerk-Treasurer Renee Caron's last regular meeting and thanked her for her 20 years of service to the Village of Elbridge.

Mayor DeCola recognized Tayler Bottar and Jessica Martinez; Barton & Loguidice. Mr. Bottar stated that the WIIA grant application is out and they are in the process of putting together the application, which is due November 22. This grant, if approved, is valued at up to \$3 million.

Mayor DeCola read Resolution #4-2021.

The resolution was offered by Trustee DeMarco, seconded by Trustee Murray, and carried on roll call vote, authorizing submission of a New York State Water Infrastructure Improvement Act (WIAA) Grant application for the Village of Elbridge, Town of Elbridge, Village of Jordan Joint Water System Improvement Project. (See Resolution #4-2021 attached.)

Mr. Bottar stated that he attended a workshop meeting last week to draft an Intermunicipal Agreement for the Joint Water District. He will e-mail a copy to Mayor DeCola and would like the Municipal Boards to review and comment.

Barton & Loguidice presented the Board with a revised Amendment #1 to the Owner-Engineer Agreement for the Joint Water System Improvement Project for their review. It includes services to install an additional 7,000 feet of new water mains, modifications to proposed water main replacement, a second chlorine booster station and their suggestion to relocate the Crossett Road pump station at an additional cost of \$310,000. It would reduce the contingency amount available to 16% and the project still needs to go to bid. Mr. Bottar stated that the Village of Jordan and the Town of Elbridge have already approved it.

A motion was offered by Trustee Ely, seconded by Trustee Murray, and carried unanimously authorizing the Mayor to execute the revised Amendment #1 to the Owner-Engineer Agreement for the Joint Water System Improvement Project

Mr Bottar and Ms. Martinez left at 7:14 p.m.

November 1, 2021 Village Board Meeting Cont.

Mayor DeCola recognized Cindy Sanderson who addressed the Board regarding speeders on Valley Drive. She states she has spoken with the State Troopers. Mayor DeCola stated he has spoken with the State Police Sergeant and that the Sheriffs are also aware of the issue. The Village has posted speed limit signs but will explore the possibility of posting more signs. Mayor DeCola encouraged Ms. Sanderson to approach the Police Sergeant again.

Mayor DeCola recognized Tim Burns who wanted to address the Board with his concerns regarding the Hourigan Manure Lagoon. Upon introduction, Trustee DeMarco did question why Mr. Burns was coming to the Village Board when the property is not in the Village and the Village Board cannot regulate it. He should be approaching other municipalities that have the ability to address the situation. Mr. Burns provided a copy of results from a FOIL request and asked that it, along with his concerns, be noted in the Village minutes. There was much discussion, including an explanation of the process of the manure lagoon by Town Councilman and local farmer Douglas Blumer. Many left the meeting at 8:15 p.m. with the exception of Douglas Blumer, Vern Richardson, Fred Weisskopf, Tim Burns, Dan Conroy and Cindy Sanderson.

A motion was offered by Trustee DeMarco, seconded by Trustee Murray, and carried unanimously to forgo the reading of the minutes from the last regular meeting on October 4, 2021.

The minutes of the last regular meeting on October 4, 2021 were accepted on a motion made by Trustee Ely, seconded by Trustee DeMarco and carried unanimously.

A motion was offered by Trustee DeMarco, seconded by Trustee Murray, and carried unanimously to forgo the reading of the minutes from the special meeting on October 13, 2021.

The minutes of the special meeting on October 13, 2021 were accepted on a motion made by Trustee DeMarco, seconded by Trustee Murray and carried unanimously.

Reports of Officers and Committees -

The Board reviewed the November Treasurer's Report and approved it on a motion made by Trustee Murray, seconded by Trustee DeMarco and carried unanimously.

There was no Code Enforcement Report.

There was no Public Works Report.

There was no Historian's Report.

Trustee Murray stated that he attended a meeting at the Town of Elbridge recently to review plans and preliminary drawings for the multi-purpose building the Town is considering. He provided copies for the Board's review.

There was no Fire Department Report.

Trustee, Mayor and Attorney Reports –

Trustee Harris - Stated the she found the American Flag pole on the corner of South Street and Main Street had broken. She gave it to Brad for repair.

Trustee Murray - Asked about the status of the speed sign. Trustee DeMarco said they have been unable to repair it so he will order a new one.

Trustee DeMarco - Nothing at this time.

Trustee Ely - Nothing to report.

Mayor DeCola - The American Flags and Veteran Banners will remain up through Veteran's Day. When those are removed the Christmas Lights will be put up.

One of the new light poles on East Main Street was damaged beyond repair as the result of a motor vehicle accident. He is awaiting the police report for the insurance claim. A new pole has been ordered, however it probably won't be installed until spring.

New Business -Trustee Harris offered a motion, seconded by Trustee DeMarco, and carried unanimously for the Board to Certify the Treasurer's Affidavit of Unpaid Village Taxes for return to the County and Relevy on the Town & County Taxes on January 1.

Gemini Farms of Elbridge has requested to enter into a five (5) year Lease Agreement with the Village of Elbridge. The Board will review the previous agreement. Other parties are interested. Trustee DeMarco will contact the FHA before the next meeting.

Trustee Ely offered a motion, seconded by Trustee Harris, and carried unanimously to add holiday Juneteenth (June 19th) to the Holiday Schedule and update the Employee Handbook.

Ms. Sanderson left the meeting at 8:33 p.m.

This money may be invested in M&T Trust Co., Elbridge Office, authorized to do business in the State of New York, and named the official bank of depository at the Annual Meeting of the Board of Trustees on <u>December 6, 2021.</u> A survey of banks will be undertaken to determine the best rate of return for large investments when appropriate.

The Village of Elbridge, as stated in New York State law, requires that the bank holding the monies or CD's provide, in writing, a statement of pledged collateral and where the collateral is being held for the amounts exceeding the \$100,000 limit insured by the Federal Deposit Insurance Corporation.

Any monies exceeding \$100,000 will require the bank to pledge security in an amount to safeguard these monies.

LATERAL RESTRICTION – CONDITIONS ON FUTURE SERVICE December 6, 2021

At the annual meeting of the Board of Trustees of the Village of Elbridge, held at the Municipal Offices, 210 West Main Street, in said Village of Elbridge, Onondaga County, New York, on Monday, the 6th day of December, 2021, commencing at 7:00 p.m., the following resolution was offered by Trustee DeMarco, who moved for its adoption, seconded by Trustee Murray, to wit:

WHEREAS The Village of Elbridge imposes the following conditions, on the management of water lines located in the Village of Elbridge, Town of Elbridge, and Village of Jordan within an agricultural district, map of which is attached to this resolution showing the boundaries of the agricultural district in relation to the parcels indicated:

- (1) The only land and/or structures which will be allowed to connect to the proposed waterline within an agricultural district will be existing structures at the time of construction, future agricultural structures, and land and structures that have already ben approved for development by the local governing body prior to the date of filing of the Notice of Intent by the municipality.
 - Land and structures that have been approved for development refer to those properties/structures that have been brought before a local governing body where approval (e.g., subdivision, site plan, special permit) is needed to move forward with project plans and the governing body has approved the action. If no local approval is required for the subdivision of land and/or the construction of structures, the municipality accepts the limitation under Public Health Law §1115 that defines a "subdivision," in part as "any tract of and which is divided into five or more parcels." Water service will not be provided to more than a total of four residences, buildings and/or structures on any tract of land which has been divided into parcels after the date of filing the NOI by the municipality, where no local approval is required and the land is located within a county adopted, State certified agricultural district.
- (2) If a significant hardship can be shown by an existing resident, the lateral restriction to the resident's property may be removed by the municipality upon approval by the Department of Agriculture and Market (Departments). It is the responsibility of the resident landowner to demonstrate that a hardship exists relative to his or her existing water supply or septic system and clearly demonstrate the need for public water service. The municipality shall develop a hardship application to be filed with the municipality, approved by the County Department of Health, and agreed to by the Department of Agricultural and Markets.
- (3) If it can be demonstrated to the Department's satisfaction that the landowner requested the county to remove his or her land from an agricultural district at the time of district review and the county legislative body refused to do so, lateral restrictions may be removed by the municipality if the Department determines that the removal of the restriction for the subject parcel(s) would not have an unreasonably adverse effect on the agricultural district.
- (4) If land is removed from a county adopted, State certified agricultural district and the district has been reviewed by the county legislative body and certified by the Commissioner for modification, lateral restrictions imposed by the municipality are no longer in effect for the parcels of land that have been removed from the agricultural district.
