**NOTICE OF PUBLIC HEARING**

**PLEASE TAKE NOTICE** that a Public Hearing will be held by the Village of Elbridge on Monday, May 2, 2022, at 8:00 p.m., at 210 West Main Street, Elbridge, New York, 13060, regarding the previous adoption of an Amendment to a Local Law of the Village of Elbridge, for the Year 2022, as follows:

*“Amendment to Local Law,  
Chapter 113 of the Village of Elbridge Code,  
entitled ‘Solid Waste,’  
Establishing a Special Assessment for Residents  
Residing in Refuse and Garbage District”*

**PLEASE TAKE FURTHER NOTICE** that the **PURPOSE** of the Public Hearing on May 2, 2022, at 8:00 p.m. is to hear any objections of Village of Elbridge residents and/or property owners, pertaining to:

- a. Such apportionment;
- b. Such Assessment Map on their respective properties.

**PLEASE TAKE FURTHER NOTICE** that copies of the following documents have been previously filed with the Village of Elbridge Clerk’s Office, and are available for public examination, at 210 West Main Street, Elbridge, New York, 13060:

- a. The Trash District Map;
- b. The amount of apportionment and assessment upon each resident; and,
- c. The New Local Law.

**PLEASE TAKE FURTHER NOTICE** that a mailing to each resident affected thereby has been transmitted to each resident ten (10) days prior to the May 2, 2022 Public Hearing.

**PLEASE TAKE FURTHER NOTICE** that the Village of Elbridge Board of Trustees may modify and correct the same Trash District Map, and add or exclude lands to or from, as the case may be, the area of local assessment, but no assessment may be further increased and no lands added thereto without an additional notice to such owners, along with an opportunity to be heard.

**PLEASE TAKE FURTHER NOTICE** that written communication from any resident and/or property owner in relation to this matter either may be filed with the Village of Elbridge Clerk’s Office or may be delivered in person by said resident and/or property owner, at such Public Hearing on May 2, 2022.

**PLEASE TAKE FURTHER NOTICE** that, after the Public Hearing on May 2, 2022, the Village of Elbridge Board of Trustees will be filing the apportionment and assessment in the Office of the Village Clerk and will Publish a Final Public Notice only (**not** a public hearing) of such completion and filing of the same in the official newspaper for the Village of Elbridge.

**PLEASE TAKE FURTHER NOTICE** that, once the Final Notice is published in the official newspaper after the May 2, 2022 Public Hearing, pursuant to New York State Village Law Section 22-2200, any person deeming himself or herself aggrieved thereby may, within 15 days of said filing of said apportionment and Trash District Map, apply to a court of record for an order of certiorari to review said assessments. The apportionment, the assessment, and the map shall be deemed final and conclusive, unless such an application has been made within 15 days of the required Publication.

**PLEASE TAKE FURTHER NOTICE** that any resident and/or property owner of the Village of Elbridge is entitled to be heard upon said matter at such Public Hearing on May 2, 2022.
