Budge Officer Fred Weisskopf and Clerk-Treasurer Kunz were also present. Also present were resident Bill Sloan and Fire Department Chief Ryan Peters.

Mayor DeCola led everyone in the Pledge of Allegiance.

A motion was offered by Trustee DeMarco, seconded by Trustee Ely, and carried unanimously to forgo the reading of the minutes from the last regular meeting on January 2 and the Special Meeting on January 24, 2024.

The minutes of the last regular meeting on January 2, 2024 and Special Meeting on January 24th were both accepted on a motion made by Trustee DeMarco seconded by Trustee Ellingworth and carried unanimously.

After review of the bills by the Board of Trustees, a motion was offered by Trustee Ely, seconded by Trustee Harris, and carried unanimously, to approve payment of February Abstract 9, in the amount of \$18,509.41 for General Fund Vouchers A252-A274, Checks 15441-15463, and \$4,571.00 for Water Fund Vouchers F87-F96, Checks 5693-5702 and including Joint Water Project vouchers totaling \$1,455.34, which will be paid upon EFC reimbursement.
