Regular Meeting, Monday, January 6, 2014

The regular meeting of the Village of Elbridge Board of Trustees was called to order at 7:00 p.m. in the Municipal Offices, 210 West Main Street. Trustees present were DeCola, Weisskopf, DeMarco and Conlan with Mayor Doerr presiding. Clerk-Treasurer Caron was also present.

Residents present were Thomas LaPrairie, Roger Swayze and John Tambroni.
William Ashby, Roger Shalala, Ben Ecker, Casey Brim, Pat & Chris Beane, Gretchen & Dan Leary, Deb Stapleton, Phil Jennings and Joe Patrick were also in attendance.

Town Clerk Deb Stapleton led everyone in the Pledge of Allegiance.

The DeMarco lease of the Sandbank Road property has expired, however due to equipment problems and weather issues they require additional time to complete their work. Stumps and debris that they are unable to grind will be moved out of site. The DeMarcos will level off a portion of the property and seed it in the spring.

Mr. Ashby expressed concerns regarding the Northern Cayuga Little League and Town Recreation programs and the use of the Seymour Lofft Park fields for the coming year. He stated that registration is scheduled to begin in February. Due to the substantial loss of revenue for the current budget the Village Board is concerned about the costs associated with the maintenance of the park. In the coming week the Village Board will evaluate costs and research options. The Village will present information to the Town of Elbridge for their January 23, 2014 meeting for consideration regarding the agreement between the Town of Elbridge and the Village of Elbridge to help defray the costs for Seymour Lofft Park.

Mayor Doerr reported that the Village has received a \$150,000.00 Emergency Services Revolving Loan which will be used to replace the roof on the Fire House.

Due to budgetary restraints the Village will only purchase the necessary life safety street signs (i.e. STOP, etc.) at this time.

Mr. Ashby, Mr. Jennings and Mr. Patrick left the meeting at 7:35 p.m. Jeanine Nolte and Daryl Pickering Jr. joined the meeting.

The minutes of the special meeting on December 16th were accepted on a motion made by Trustee Weisskopf, seconded by Trustee DeMarco and carried unanimously.

Reports of Officers and Committees -

The Board reviewed the Treasurer's report and approved it on a motion made by Trustee DeCola, seconded by Trustee Weisskopf and carried unanimously.

Trustee DeCola presented the Code Enforcement Report for December, who moved for its acceptance, seconded by Trustee DeMarco and carried unanimously.

Trustee Weisskopf presented the Public Works Report for December, who moved for its acceptance, seconded by Trustee Conlan and carried unanimously.

Trustee, Mayor and Attorney Reports

<u>Trustee DeCola</u> – Attorney Armani has requested the Village obtain a signed Settlement Agreement from OCEBA in addition to their letter dated December 18, 2013. He has been in contact with OCEBA and is awaiting a reply.

He has an appointment with a representative from Eastern Shores/ESIP regarding a premium adjustment for the Elbridge Fire Department's insurance. This premium is based on population served.

Fire Chief Robert Chuff, Paul Czarnecki, Patrick Ely, Jarrod Smith and Gordon Franz arrived at 7:45 p.m.

Chief Chuff presented the Fire Department Report for December. Trustee DeMarco moved for its acceptance, seconded by Trustee Weisskopf and carried unanimously.

Trustee Weisskopf presented the Chief with preliminary budget figures for the coming year for the Fire Department's review.

January 6, 2014 Village Board Meeting Cont.

Mayor Doerr read Resolution #3-14. This is an exploratory resolution regarding TLC ambulance services. There was some discussion.

The resolution was offered by Trustee DeMarco, seconded by Trustee Conlan, and carried on roll call vote, subject to Attorney review and reconstruction. (See Resolution #3-14 attached.)

Chief Chuff, Mr. Czarnecki, Mr. Ely, Mr. Smith, Mr. Franz, Mr. Ecker and Mr. Brim left the meeting at 8:11 p.m.

Trustee Weisskopf – nothing at this time.

<u>Trustee DeMarco</u> – nothing to report.

<u>Trustee Conlan</u> – He presented the Board with an estimate of costs, not including AE Fees or a construction contingency, to replace the roof on the firehouse for their review. Klepper, Hahn & Hyatt will need to provide the Village with their fee schedule for the project.

LT2 Maintenance.

A motion was offered by Trustee DeCola, seconded by Trustee Weisskopf, and carried unanimously authorizing Mayor Doerr to send letters of congratulations on behalf of the Board of Trustees to Nathan G. Bugin, Ryan D. Blumer and Nathan A. Johnson; Boy Scout Troop 52, acknowledging their hard work and dedication to earn the rank of Eagle Scout.

Mayor Doerr read Resolution #1-14.

The resolution was offered by Trustee Weisskopf, seconded by Trustee DeMarco, and carried on roll call vote, setting the polling place and hours for the March 18, 2014, Regular Village Election. (See Resolution #1-14 attached.)

Mayor Doerr read Resolution #2-14.

The resolution was offered by Trustee Conlan, seconded by Trustee Weisskopf, and carried on roll call vote, appointing Diana E. Rynkiewicz and Jackie L. Ingerson election inspectors designating Mrs. Rynkiewicz Chairman, and Susan C. Hartwell as alternate inspector and/or poll clerk, and setting their rate of compensation at \$8.00 per hour. Setting budget meetings for the months of January and February was discussed. The first budget workshop will be Tuesday, January 14, 2014 at 7:15 p.m.

Regular Meeting, Monday, February 3, 2014

The regular meeting of the Village of Elbridge Board of Trustees was called to order at 7:00 p.m. in the Municipal Offices, 210 West Main Street. Trustees present were DeCola, Weisskopf and Conlan with Mayor Doerr presiding. Clerk-Treasurer Caron was also present. Trustee DeMarco was absent.

Residents present were Ally Pickering, Roger Swayze, Tom LaPrairie and Floyd Duger. Chris Beane and Dan Leary were also in attendance.

Ally Pickering led everyone in the Pledge of Allegiance.

There were no public comments.

Jeanine Nolte joined the meeting at 7:05 p.m.

The minutes of the regular meeting on January 6th and special meeting on January 14th were accepted on a motion made by Trustee Weisskopf, seconded by Trustee DeCola and carried.

Reports of Officers and Committees -

The Board reviewed the Treasurer's report and approved it on a motion made by Trustee Weisskopf, seconded by Trustee Conlan and carried.

Trustee DeCola presented the Code Enforcement Report for January, who moved for its acceptance, seconded by Trustee Conlan and carried.

There was no written Public Works Report. Trustee Weisskopf presented a Public Works Report for January; which included numerous water main breaks, snow plowing and low water pressure problems for Kingston Road customers then moved for its acceptance as presented, seconded by Trustee Conlan and carried.

Trustee, Mayor and Attorney Reports

<u>Trustee DeCola</u> – He has had some discussion with the Town regarding the Code's Contract. The Town Board has rejected the Village's proposed fee of \$500.00 per month. They are looking to establish a fee based on five (5) hours of service each week. He will monitor this over the next few months to see if it is accurate.

A motion was offered by Trustee DeCola, seconded by Trustee Weisskopf, and carried to reestablish a Code Enforcement Service Agreement with the Town of Elbridge for the remainder of the fiscal year payable February – May at a rate of \$650.00 per month.

Trustee DeCola has contacted the County regarding the 2013 Workers' Compensation Assessment. We receive one bill now for both the Village and the Fire Department. Each year's assessment is based on a three year rolling average. Barring any claims, the coming years' assessments should significantly decrease.

<u>Trustee Weisskopf</u> – The Town will approve an increase to pay the Village of Elbridge \$2,000.00 to help defray the costs of the New York State Trooper's Sub-Station.

<u>Trustee Conlan</u> – The Village is not ready to advertise for bids for the fire house roof project. He will continue discussions with Klepper, Hahn & Hyatt about preparation of the necessary documents.

The Village has experienced numerous water main breaks over the last few weeks. The most recent break on South Street created quite a mess at the intersection of Route 5 and South St. Village DPW had to work with State and County DOT, Village of Jordan DPW and the Fire Department during the repair. The Board would like to thank the Elbridge Fire Department/Fire Police for their help that evening.

<u>Mayor Doerr</u> – He received the Community Development Grant Application; however the Village of Elbridge is ineligible so will not apply.

Old Business

The Board has received no further correspondence from the Onondaga County Employee Benefits Association.

The Board is awaiting notification regarding any action relative to 116 East Main Street.

Clough Harbour & Associates continues to work on the Comprehensive Plan Update and is finalizing the Planned Unit Development (PUD) standards.

New Business

A motion was offered by Trustee Conlan, seconded by Trustee Weisskopf, and carried authorizing execution of the Williamson Law Book Software Support Contracts.

Trustee Weisskopf offered a motion, seconded by Trustee DeCola, and carried to pay Philip E. Pellizzari, Certified Public Accountant \$550.00 for his services.

Attorney Harry V. Armani joined the meeting at 7:33 p.m.

Attorney Armani advised the Board to reject the bill from Jordan Fire Department for replacement of damaged hose and a pager.
